DELEGATE CONTRACT

Before Opening Ceremonies, all delegates must email this Delegate Contract signed by both the delegate and the delegate’s parent or legal guardian to our Undersecretary-General of External Affairs, Justin Fernando (externalaffairs@msumun.org), or have their advisor present this contract during registration on March 18th. Delegates without a signed Delegate Contract will not receive their identification credentials, and will be unable to participate in MSUMUN XXI committee sessions and official functions. Advisors are encouraged to discuss these rules with their students, and to set additional expectations as seen fit.

I _____, as a delegate attending MSUMUN XXI and a student at

_____, agree to abide by the following rules and expectations:

1. No alcohol or illegal substances, as defined by the US Federal Government or State of Michigan, may be possessed or consumed during the duration of the Conference, on any sites of MSUMUN XXI. Any violations of this rule shall be grounds for immediate dismissal from the Conference;
2. No smoking of any kind shall be allowed at the Kellogg Hotel and Conference Center, on the grounds of Michigan State University, or on camera during a virtual meeting while the Conference is in session, while the Conference is in session. Smoking in any form, including but not limited to tobacco, electronic cigarettes, and vapes, are prohibited on the campus of Michigan State University;
3. Western business attire is to be worn during all committee sessions and at any other official Conference function as distinguished by the Secretariat, with the exception of sPARTY;
4. Identification credentials are to be worn above the waist and must be presented to MSUMUN Staff and/or Secretariat members upon request;
5. Curfews and noise curfews established by the Secretariat as well as faculty Advisors must be followed out of respect for Conference delegates and other guests of the hotels;
6. MSUMUN and/or any of its affiliate programs or Staff are not liable for any misconduct, theft, or injury that may occur while participation in the Conference or on Conference grounds;
7. Discrimination on the basis of age, color, gender, gender identity, disability status, height, marital status, national origin, political persuasion, race, religion, sexual orientation, veteran status, or weight will not be tolerated. If observed, I will notify a MSUMUN XXI Staff or Secretariat member immediately;
8. I agree that MSUMUN may release my picture on their official Conference website (www.msumun.org) or to press sources, including print and social media, for Conference related purposes.

I understand that these policies are not to be seen as replacements for any set forth by my school or Advisor, but are an extension set forth by the Secretariat of MSUMUN XXI. Additionally, these are in addendum to the guidelines and rules set forth in the delegate handbook. I understand that a failure to follow these policies may lead to expulsion from the Conference or other appropriate forms of action as determined by the Conference Secretariat and Advisors. I fully understand all of the aforementioned rules, and realize the consequences if these rules are violated.
